

CasVersa Privacy Policy

CasaVersa, Ltd. ("**CasaVersa**") provides an Internet platform for exchanging homes while travelling (the "**Platform**"). CasaVersa respects your right to privacy. Your ability to make informed choices about the uses of your information is important to us. This privacy policy details how we collect, use and store information and data that we receive. As used in this privacy policy, "**Personal Information**" means information that can be directly associated with a specific person or entity such as a name, address, telephone number, or e-mail address.

Information We Collect

If you use the Platform by logging in through "Facebook Connect" or another social network, we receive personal information about you which is provided by such social network. Please check the policies of such social network in order to understand what information we receive.

We collect and store your activity while using the Platform, including your name, contact information, provided photographs, your location data, and information regarding your other activities such as where, when and to whom you have offered or accepted accommodation services. We also collect other information that you may provide through the Platform, such as regarding materials you post or upload to any forum.

The Platform will also record certain information automatically, such as your IP address, mobile device or computer, operating system and browser. In addition, we collect any information you provide when you contact us for any reason. You are not required by law to provide us with any of the information described herein, but by using the Platform you agree to provide us with such information.

How We Use Information

We will not provide your contact information to any individual to whom you have agreed to provide accommodation services, or from who you have agreed to accept accommodation services. It is your responsibility to decide when and to whom you will share your contact information in this manner.

We will not share your Personal Information with third parties without your explicit permission, except when required by law, regulation, subpoena or court order or as otherwise expressly set forth herein. We may use Personal Information and other information internally – for example, to help diagnose problems with our servers, and to make the Platform more useful for you and for our other customers, or to recommend to you services or accommodations in which you may be interested.

In addition, by analyzing all information we receive, we may compile statistical information across a variety of users ("**Statistical Information**"). Statistical Information helps understand trends and customer needs so that new services can be considered and so the Platforms and associated services can be tailored to customer desires. We may share Statistical Information with our partners, pursuant to commercial terms that we determine in our sole discretion. In addition, we may provide any information to third parties, so long as we have removed any information that identifies any particular individual or user, such as a name, address or contact information.

Communities

When you post or upload materials to any publicly available area of the Platform, please remember that any information disclosed in this venue may be automatically made public, and such information

will not be considered Personal Information by us. You should exercise caution when disclosing any information (including Personal Information) in such a venue, as you do not know who will access or use such information and for what purposes.

How we Protect Information

We follow generally accepted industry standards to protect the Personal Information submitted to us, both during transmission and once we receive it. However, no method of transmission over the Internet, or method of electronic storage is 100% secure. Therefore, while we strive to use commercially acceptable means to protect your Personal Information, we cannot guarantee its absolute security.

We will delete any Personal Information provided to us by a user upon the receipt of a written request by such user. We cannot restore information once it has been deleted.

Cookies

A cookie is a small piece of text that is sent to a visitor's browser. The browser provides this piece of text to the device of the originating visitor when this visitor returns. A "persistent" cookie may be used to help save your settings and customizations across visits. Most Web browsers are initially configured to accept cookies, but you can change this setting so your browser either refuses all cookies or informs you when a cookie is being sent. Also, you are free to delete any existing cookies at any time. Please note that some features of the Site may not function properly when cookies are disabled or removed.

Children
